Each participant will be informed of any such changes as soon as possible by V.S.O.

Prices:

Our prices are expressed in Euro (€). They are established using current exchange rates and notably those for the US Dollar, in force on 01/08/06. A significant change in the exchange rate is therefore liable to alter the sale price of the holiday or trip concerned. For each customer who have already registered and paid an increase in the price of his holiday or trip may only be made up to 30 days before the date of departure.

Reservation:

Please send the enclosed order form by post or by fax with the deposit corresponding to your reservation. No registration will be taken into account without payment, thus, we will not allow you to take options. As soon as we receive your payment, we will send you our confirmation and the corresponding invoice by return.

Payment:

A deposit of 30% on reservation, the remainder to reach us 30 days before departure.

Cancellation fees:

In case of cancellation by the customer, repayment of the sums paid minus the following amounts (cancellation fees) as compensation corresponding to the time remaining between the date of cancellation and the date of departure.

- ◆ More than 60 days before departure: 80 € per person
- ◆ 60 to 30 days before departure: 25% of the total cost
- ◆ 29 to 21 days before departure: 50% of the total cost
- ◆ 21 to 10 days before departure: 90% of the total cost
- ◆ 9 days before departure: 100% of the total cost

Optional cancellation insurance:

We advise you, on reservation, to take out insurance to cover risk for cancellation and luggage (illness, accident, death, and loss of luggage). Not included.

Travel documents:

As a general rule, tickets and vouchers will be given to you at the airport on the day of departure.

Cancellation by the organiser:

The customer can not claim compensation if cancellation is caused by circumstances outside the organizer's control or for reasons connected with passenger safety. The same applies if the trip is cancelled due to insufficient numbers of participants 21 days or more before departure.

Transport:

Special conditions for chartered and regular flights: no seats unused on the outward or return journey can be refunded (even in the case of postponement). Airports: the name of the airport, when the town in question has several, is mentioned for reference only and may be altered, without giving rise to compensation. In the case of a change of airport in Paris in particular (Orly, Roissy) transfer charges (taxi, bus, car park fees ...) are at the customer's expense.

1- Preliminary information:

For all flights, VSO charters aeroplanes from French airline companies, i.e., Aigle Azur (AAF), Air Méditerranée (BIE), Blue Line (BLE), Europ Airpost (FPO) or Star Airlines (SEU)

2- Air line company confirmation

« In accordance with Decree n°2006-315 of March 17 2006, the customer is informed of the identity of the contracted or operating airline carrier(s), likely to perform the flight. The ticket seller will inform the customer of the identity of the airline company that will actually operate the flight(s). In the case of a change in the identity of the operating airline carrier, the customer will be informed of this change by the contracted airline carrier or by the travel agent, by all appropriate means, as soon as this information is made known to them. »

In accordance with articles 1, 2 and 5 of Decree n°2006-315 of March 17 2006, V.S.O. undertakes to communicate in writing to its customers, on the airport convocation and at the latest 8 days before departure, confirmation of the identity of the contracted airline carrier(s), and all operating airline carrier(s), likely to perform the flight.
